**AGREEMENT ON VOCATIONAL, SCIENTIFIC,
AND EDUCATIONAL COOPERATION**

Prologue

Article 1

This Agreement shall aim to enhance cooperation in the field of training, education, research, publishing and cultural relations between the Faculty of Law, Uzhgorod National University (hereinafter called as "Faculty") and Department of Law, Pisa University (hereinafter called as "Department").

Subject Matter of the Agreement

Article 2

The cooperation between the Faculty of Law, Uzhgorod National University and Department of law, University of Pisa shall be conducted in the following areas:

- a) the organization of collaborative vocational education through global trainings and capacity building programs;
- b) the development and execution of a joint/collaborative Certificate or Diploma program in English medium for international students;
- c) the development and implementation of joint or collaborative scientific/action research project(s);

- d) the cooperation in publishing of the scientific journals, and joint publishing of new journal, textbook or review;
- e) the participation of students and teachers in various relevant activities of both the institutions.

Cooperation in Vocational Education

Article 3

- (1) A cooperation for vocational education between the Faculty and the Department shall be mainly realized by organizing joint or collaborative Summer Schools, Academies, vocational and scientific meetings, conferences, and seminars.

Cooperation in Scientific Education

Article 4

- (1) Scientific cooperation between the Faculty and the Department shall include the development and execution of a joint/collaborative Certificate or Diploma program in English medium for international students and participants.

Cooperation in Publishing Activities

Article 5

- (1) A cooperation between the Faculty and the Department shall include the cooperation in existing publications, and to publish a new journal, textbook or review on mutually identified/agreed subject/topic.

Other Forms of Cooperation

Article 6

- (1) The Faculty and the Department shall cooperate in supporting each other in the form of providing Visiting Professor(s) for delivering (in-person and online) open and specialized lectures to their students, researchers and teachers. Specialized training courses or events can also be developed, and the Visiting Professor(s) may act as expert(s)/facilitator(s) for such training sessions. Visiting Professor's may be for short-term or long-term and should be bilaterally depending on the academic and professional needs of either Party.
- (2) The Faculty and the Department shall cooperate to build skills and capacities to raise funding and other resources necessary for the development of the Faculty. In this context, an inspired team of the Faculty may be trained and educated chiefly on two key aspects: i) Linking with Multilateral and Bilateral Donors, ii) Project Partnerships with Foreign Universities and Networks.
- (3) Other Form of mutual cooperation may be innovated and developed further.

Final Provisions

Article 7

- (1) This Agreement shall be concluded for an indefinite period. Changes, additions or subtractions can be made to this Agreement through ADDENDUM(S) mutually agreed between the two Parties.
- (2) The Agreement may be terminated in writing by either Party. The Agreement shall be repealed within a 6 month period commencing on the first day of the month following the month wherein the written notice was delivered to the other Party.

Article 8


This Agreement shall enter into force subsequent to the signature by both Parties.


Article 9

This Agreement can be elaborated, if necessary, in supplementary documents written in the English language.
